



This comprehensive judging program has been identified as the worlds' best practice in the development of quality accredited officials.

The ISA are committed to the continued success of surfing as a sport worldwide and recognize the need for one accreditation course.

The basic responsibilities of each Licensee are listed below:

- To pay the \$500 USD License fee to Surfing Australia each December upon receiving the License Invoice.
- To provide a list of all course participants directly after each course and the course royalty registration fee (\$20) per person & a Spreadsheet formatted with Full name, email address and level of accreditation/registration (level 1,2 or 3)
- To maintain a data base of accredited Judges that has completed the International Judging course. This will be your National Judges Register.
- Each December the licensee will contact all accredited Judges on your national Judges Register. All Judges must be re-registered every December with your NGB. Your National Judging register fee is set by your NGB.
- In January each year, the full list of all registered judges is sent to Surfing Australia along with \$10 USD per registered Judge. This is the yearly International registration fee.
- Every licensee must comply with all Judging License contractual requirements and promptly pay all fees upon receipt of invoices. All judging fees can be paid online www.survingaustralia.com

The responsibilities of Surfing Australia as managers of the International Judging development programs:

- Provide full administration and consultancy support to the Licensed NGB which includes:
- Each January Surfing Australia will provide all updated resources upon receiving payment of the \$500 USD yearly License fee. (updated course manuals, DVD and Power point CD)
- After every course and upon receiving the spreadsheet of course participants and details, Surfing Australia will print and provide the International Judging Identification card for each course participant. This card is numbered and personalized and will expire in the next December.
- Each January upon receiving the National Judging Register list from the licensee and \$10 USD payment per judge, Surfing Australia will print and provide each Judge with the International Judging Identification card. This card is numbered and personalized.
- All National Judges register lists are formatted and are sent to the ISA office to be included on the ISA International Judges Register. Available for viewing on the ISA website.
- All registered Judges are included in the International Judges Exchange program data base. This is managed by Surfing Australia.

ISA Judging License includes full administration and consultancy support and the resources to maintain and conduct professional Judging development courses and develop the administration infrastructure.

- 1 Presenter / Teacher Manual and syllabus.
- 1 CD with judging manuals, certificates to provide quality copies for course participants.
- 1 DVD containing exercises including:
 - (i) Identification of Manoeuvres
 - (ii) The Judging Criteria
 - (iii) Comparing single manoeuvres
 - (iv) Comparing and separation of waves
 - (v) Interference Rules
 - (vi) Practical judging heat scenarios 1,2 ,3 & 4

- 1 CD with full power-point presentation to aid in course delivery.
- Documentation on how to implement the ISA Judging Development Program in your country/region. All resources are available in several languages.

The renewable term of the license contract will be three years based on performance of the licensee. Payment is invoiced every December & continues yearly across renewable periods as the license progresses.

The International registration program is crucial for the ongoing development of the ISA data base and the International exchange programs between all of our licensed partners.

All ISA courses and registration fees are budgeted to provide a reasonable financial return to all parties involved in preparation, administration and delivery. Consultancy support is available to initiate and develop the programs on request to Glen Elliott on behalf of the ISA.
